- iii. Announcement to be made in October for Award presentation in November


f. UPPAC


- i. President's meeting in July:

 - iv. Idea for questions: When did you start the process? What stage you are at? What was the result, if reached the end? What kind of updates have you received? What type of survey did you complete? (in-person interview, online survey, etc
 - **v.** Two paths for survey? One path for anyone who has started or completed the process and other for those who haven't yet?

- **vi.** Potential classifications: AP's, civil service, faculty, converted from AP to civil service, hiring managers, HR. Want to get different perspectives on how people view this process.

VIII. New Items - Board of Trustees Meeting

- a. Financial situation of the hospital.
 - i. Chairman Kennedy made a point about the fringe benefits of hospital employees not being on the books. Hospital seems to be right on the edge of budget, but they would actually be about 20 million in the red if you factored in all those benefits. They are looking at how they are reporting that.
- b. Undocumented students presented about their personal situations and the impact it has on them academically.
 - Holding 2 or 3 jobs and have attended community colleges, they have no resources such as FAFSA because of documentation status. Would like some opportunity to draw on funds from the University.
